1. The above prescribed semester fees is for the Integrated First Degree (B.E. Computer Science, B.E. Electrical and Electronics, B.E. Electronics and Communication, and B.E. Mechanical) students admitted in the academic year 2026-27 (For BITS-UB 2+2 International Collaborative Programmes students at BITS Pilani only). For these students, the Semester Tuition, Summer Term and Hostel fees will be revised upward every year. The details of semester tuition fee and summer term fee is given below (unless the government announces any new levy/tax, which will be passed on to all existing students irrespective of their year of entry).
2. Summer Term Tuition Fee will be 35% of Semester Tuition Fee in corresponding Academic Year. All three Indian campuses of BITS Pilani will have the same summer term fee in an academic year. It is to be noted that every summer term is not part of the academic calendar except where specifically stated. Though the prescribed summer term fee is mentioned above, depending on the requirement of registration of a student in a given summer term, he/she will be required to pay summer term fee for that particular academic year only.
3. All fees are to be paid in advance. Only caution deposit and mess advance are refundable after adjustment of dues at the time of graduation or withdrawal from the Institute. This applies to prospective candidates who are seeking admission as well as ongoing students of the Institute.
4. Students will pay the BITS scheduled tuition and fees for the first two years. Once they are admitted into UB, students will pay the UB scheduled tuition and fees for nonresident (international) students. The current nonresident tuition and other fees per semester/academic year fees payable to University at Buffalo for the study period of years 3 and year 4 by all students to be admitted in the academic year 2026-2027 in the First Degree Programmes (B.E. Computer Science, BE Mechanical, BE Electrical and Electronics, BE Electronics and Communication) through UBITS 2+2 International Collaborative Programmes can be found at <https://www.buffalo.edu/studentaccounts/tuition-and-fees/fall.non-resident-full-time.html>. UB tuition and fees increase each year and are finalized just prior to the start of the academic year in late August. **Over the past five years, UB tuition and fee increases have typically been between 2 and 4% per year.**

Scholarships

Students participating in the UBITS 2+2 Engineering Cohort programme will be eligible for the UB Engineering Cohort Merit Scholarship to University at Buffalo. UB Engineering Cohort Merit Scholarship levels are based upon successful engagement and academic performance in the first 2-year component of the programme at BITS Pilani. All students who transfer to UB will receive a UBITS Scholarship of US\$10,000, supplemented by a US\$2,000 UBITS Merit Scholarship (total of US\$12,000) for each of their two years at UB - this will be reflected in their I-20. In addition, the top 25% of UBITS students, as determined by BITS and based on their BITS CGPA after the completion of the first two years, will also receive a UBITS Merit Scholarship of US\$3,000 for a total scholarship award of US\$15,000 per year for two years; this merit scholarship will be awarded in summer 2026, once CGPAs for the first two years are determined.

*** To maintain the scholarship, UBITS students must remain in good academic standing, with a UB GPA of at least 3.0.**

- major in an engineering discipline at University at Buffalo under UBITS 2+2 International Collaborative Programmes)
